### **RESOLUTION 2024-01**

## A RESOLUTION AMENDING THE ANNUAL ROAD ASSESSMENT AND AUTHORIZING THE IMPOSITION OF LATE FEES FOR THE TIMBERLINE SPECIAL SERVICE DISTRICT

## February 21, 2024

## RECITALS

**WHEREAS**, the TIMBERLINE SPECIAL SERVICE DISTRICT ("TSSD") is a special service district duly organized under the laws of the State of Utah as a public body corporate and politic; and

**WHEREAS**, pursuant to Utah Code § 17D-1-103(2)(o), TSSD is authorized to impose fees or charges or both for commodities, services, or facilities it provides; and

**WHEREAS,** TSSD bills all property owners inside its boundaries for an Annual Road Assessment ("ARA"), which amount is designed to stabilize current cash flow trends and is to be based on a ten (10) year cost projection and an analysis of the five (5) preceding years of expenses; and

WHEREAS, the ARA is assessed on a per-lot basis; and

**WHEREAS**, in recent years TSSD has performed major road improvements and assumed extensive equipment repairs without seeking to increase the ARA; and

**WHEREAS,** TSSD reserve funds have been substantially reduced in recent years due to increased costs for snow removal services, increased costs of tractor repairs, and a change in road service type; and

**WHEREAS**, an increase in the ARA, by means of an amendment to the ARA, is necessary to not only maintain TSSD service levels but also meet current and future operational goals; and

**WHEREAS,** TSSD's ability to meet its financial obligations is jeopardized by delinquent ARA payments, insofar as the ARA is TSSD's primary funding source; and

**WHEREAS,** pursuant to Utah Code § 17B-1-902.1(2), the TSSD Administrative Control Board ("TSSD ACB") has deemed it necessary to authorize and, where appropriate, to charge and collect a one-time penalty of 8% for any past-due ARA fees (the "Late Fee"). This is to encourage prompt payment of the ARA; and

WHEREAS, the TSSD ACB has reviewed the proposed Amended ARA and Late Fee, and held a lawfully noticed public hearing on February 21, 2024; and

WHEREAS, the TSSD ACB believes the Amended ARA and Late Fee to be in the best interests of TSSD and the community it services.

**NOW THEREFORE BE IT RESOLVED** BY THE TIMBERLINE SPECIAL SERVICE DISTRICT ADMINISTRATIVE CONTROL BOARD:

- 1. That the Amended Annual Road Assessment, as detailed in Exhibit A attached hereto, is hereby adopted in its entirety,
- 2. That the Late Fee, as detailed in Exhibit A attached hereto, is hereby adopted in its entirety, and
- The Amended Annual Road Assessment and Late Fee described in the attached 3. Exhibit A shall become effective thirty (30) days from the adoption of this Resolution

# TIMBERLINE SPECIAL SERVICE DISTRICT

## AMENDED ANNUAL ROAD ASSESSMENT

## AND LATE FEE

The Annual Road Assessment shall be amended from the prior amount of \$942.80 to the <u>new amount of \$1,060.65</u>, which shall be assessed on a per-lot basis. This amendment shall be effective starting with all 2024 Assessments and will be due by March 31, 2024, and March 31 of each year thereafter unless and until subsequently amended. No 10% discount will be offered. A one-time penalty charge of 8% will be imposed for any Annual Road Assessment not received by April 30, 2024.
